

Agreement on personal data processing

Owner of personal data

A person who visited the site <http://fenixtravel.ru> on the Internet and provided his personal data to the Operator (hereinafter referred to as the "User").

User:

Confirms that the personal data indicated by him belongs to him personally.

Acknowledges and confirms that he carefully and fully read this User Agreement and the conditions for processing his personal data contained therein, indicated by him in the fields of online forms on the site.

It acknowledges and confirms that all the provisions of this User Agreement and the conditions for the processing of his personal data are clear to him.

Agrees that the Site will process the provided personal data in order to register the User on the Site.

Agrees to the conditions for the processing of personal data without any reservations or restrictions.

The present consent of the User is applied in relation to the processing of the following personal data:

e-mail addresses (E-mail);
as well as other personal data received from User.

Purpose of processing personal data

Providing high quality service for User. Answer the questions that the User asked the Operator. Conduct a survey among visitors to the Site about the quality of Operator's services. These actions may be performed by the Operator or other third parties involved by the Operator in accordance with the legislation of the Russian Federation, by e-mail, sms-messages, mailing lists, phone calls, by any other means of communication. The user gives his consent to the processing of his personal data, namely the commission of the actions provided for in paragraph 3 of paragraph 1 of Art. 3 of the Federal Law of July 27, 2006

The User’s consent to the processing of personal data is specific, informed and conscious.

List of actions with personal data (processing of personal data)

Revocation of User Agreement

Consent can be revoked by the personal data subject by sending a written application to Phoenix LLC. Revocation of consent to the processing of personal data can be carried out by sending the appropriate order in simple written form to the e-mail address (e-mail) fenixtravelooo@gmail.com.
